For valuable consideration, in compliance with the condition of approval for a City of Benicia Accessory Dwelling Unit Regulation in the Benicia Municipal Code providing for the construction of a secondary or accessory dwelling unit on the above-described property, the undersigned hereby covenants, acknowledges and agrees that:

- 1. The rented unit shall not be rented for any period less than thirty days at a time.
- 2. The accessory dwelling unit shall not be sold separately from the primary dwelling.

The purpose of this Deed Restriction is to provide notice and disclosure to subsequent purchasers or transferees of limitations associated with the real property.

This covenant shall run with the land and shall be binding upon ourselves, our tenants and any future owners and tenants, their successors, heirs or assigns and shall continue in effect unless otherwise released by the authority of the City of Benicia in writing. Any lease of said specified parcel shall be subject to this restriction, which is made for the general benefit of the community. In the event that the owners, their heirs, assigns or successors in interest shall fail to abide by any of the covenants hereunder, they hereby agree to pay all costs and expenses incurred by the City in securing performance of such obligation, including reasonable attorney's fees and costs.
