

# **Public Notice to Telecommunications Service Providers**


NOTICE IS HEREBY GIVEN that the Public Works Department of the City of South San Francisco, San Mateo County, California, pursuant its Open Trench Notification Process, is accepting Notices of Intent to Participate from Telecommunications Service Providers for collocating telecommunication facilities in the public right-of-way as part of the Zayo Group Project # FS04X052 located on the following Public Streets:

320 Shaw Road from San Mateo Avenue to Walnut Street

## Description of Work:

Zayo to trench and place 1132 LF and install (2) 1.25" PVC, place (N) riser's, place (N) SB traffic rated w/ slack loops, locate, intercept (E) CNDT, splice and pull slack, place (1) 6.6M strand w/ (1) 144 fiber, aerial attachment of wireline, traffic control.

In order to participate in the above referenced project, Telecommunications Service Providers must submit the attached Notice of Intent to Participate application by (10:00am on Thursday, October 10, 2019) at the office of the City of South San Francisco Engineering Division at the City Hall Annex, 315 Maple Avenue, South San Francisco, California, 94080.

Those Telecommunications Companies that submit a Notice of Intent to Participate and meet the criteria established by the City as being a competent service provider will be notified within 14 calendar days of the due date of the Notice of Intent and will be invited to participate in the project. It is the responsibility of the <u>Zayo Group</u> and respondents to negotiate the scope and terms of collocation work in good faith. If a respondent believes that the <u>Zayo Group</u> is not negotiating in good faith, then a protest detailing the dispute may be submitted to the Public Works Department.

## **Description of Work:**

Zayo to trench and place 1132 LF and install (2) 1.25" PVC, place (N) riser's, place (N) SB traffic rated w/ slack loops, locate, intercept (E) CNDT, splice and pull slack, place (1) 6.6M strand w/ (1) 144 fiber, aerial attachment of wireline, traffic control.

It is understood that the scope and terms of the collocation work will be negotiated in good faith directly with the Zayo Group. It is also understood that all Telecommunications Service Providers require an executed Encroachment Agreement with the City of South San Francisco prior to the installation of any telecommunication facilities in the Public right-of-way.
